11. Flagpole project update: Flagpole arrived week after Veterans Day 2019. It is currently in storage at the Canfield Fire Department. When the rain stops and the Green dries enough that equipment can be driven on it without damage, Greg Parisi will erect the Flagpole for us. Vice Cdmr Coleman is coordinating with Mr. Parisi on what is needed. City will map out underground utilities. Mr. Parisi will coordinate with concrete supplier. Lighting will have to be installed later.
