b. Chaplain Duffett and Bernie Kosar Sr. reported back from meeting with Superintendent Knoll. This last Friday met with superintendent, and also there was County Educational Center, MCCTC. Superintendent wants to start putting up banners of veterans, and working with gold star families. Wants to involve Buckeye Boys/Girls State, Oratorical contest participants, flag pole project. The chaplain needs to create a list for the superintendent as he is very interested in working with veterans and the American Legion. Students are tested out for Legion gov't tests.

- c. Discuss about calling members for Buddy checks. First Vice had about 8 guys, no problems. Other reports included a stroke victim who is doing fine, some had no phone numbers. Some did not return calls. One heart surgery patient who is doing fine. Chaplain received good feedback as well. People were appreciative for the calls.
- d. Dominic updated members about Veterans Day Activities. Veteran pins, packets, Canfield school students made cards for the vets. COVID19 preventing personal visits. Both American Legion and VFW sponsor these gifts. Will get business cards and pencils from local county veterans association for the packets as well.
- e. First Vice Commander Coleman updated Veterans Day activities with schools. Last meeting we mentioned if schools would be live or virtual and if we would be allowed. We considered doing a virtual presentation. We could have members giving a few minutes presentation of what we did. DAV has preprepared videos, as does American Legion (national). First Vice is afraid a video presentation of members would be too choppy and not as professional as he would like. We could put out links for them to view the professional videos from the National organizations.
- f. Buckeye Boys State 2021. Cmdr Kubitza contacted Christie White who handles the BBS program. She says that probably June 13 will be BBS for 2021, and currently is looking to be a go.
